Subject: Changes to Coverage of Diabetes Equipment and Supplies

Delaware S.B. 316, signed by Governor Carney in October 2022, caps the amount that an individual in our AmeriHealth Caritas Next Delaware health plans will have to pay out-of-pocket for certain diabetes equipment and supplies at \$35 per month. These supplies include blood glucose monitors & strips, urine testing strips, syringes, continuous glucose monitors & supplies, and insulin pump supplies.

So that AmeriHealth Caritas Next can properly track a member's total out-of-pocket costs, **effective June 1**, **2024**, AmeriHealth Caritas Next will cover these supplies only when obtained from a pharmacy provider. Effective June 1, 2024, please direct AmeriHealth Caritas Next members to the pharmacy to obtain any of the below items.
