What is the overall deductible ?	In Network: \$6,000/Individual, \$12,000/Family Out of Network: Not Covered	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care/screening /immunization, children's eye exam and glasses, Primary Care, Specialist Care , Urgent Care , Rehabilitation , Habilitation services , Mental/Behavioral Health Office Visits , and Substance Abuse Office Visits do not apply toward the deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . If you have other family members in this plan , they have to meet their own out-of-pocket limit until the overall family out-of-pocket limit has been met.
