

Follow-Up After Hospitalization for Mental Illness (FUH)

Members 6 years of age and older who were hospitalized for treatment of selected mental illness or intentional self-harm diagnoses and who had a follow-up visit with a mental health provider.

Two rates are reported:

1. The percentage of discharges for which the member received follow-up within 30 (calendar) days of discharge.
2. The percentage of discharges for which the member received follow-up within seven (calendar) days of discharge.

Visits that occur on the date of discharge are unacceptable.

Key updates for HEDIS Measurement Year 2025

Expanded denominator criteria:

- Intentional self-harm diagnosis are now included in any position on the inpatient claim, not just the principal diagnosis.
- Phobia and anxiety diagnoses have been added to the mental illness value set.
- Suicidal ideation codes are now included (R45.851).

Enhanced numerator

- Follow-up visits with any diagnosis of mental illness or intentional self-harm are now counted, regardless of the diagnosis position on the claim.
- Additional care settings have been added to the numerator, including:
 - ▢ Residential treatment services
 - ▢ Peer support services
 - ▢ Occupational therapy services for mental health disorders
 - ▢ Transitional care management services with a mental health diagnosis
 - ▢ Psychiatric collaborative care management

Follow-Up After Emergency Department Visit for Substance Use (FUA)

Formerly Follow-up After Emergency Department Visit for Alcohol and Other Drug Abuse or Dependence

Members 13 years of age and older with a principal diagnosis of substance use disorder (SUD), or any diagnosis of drug overdose during an emergency department (ED) visit.

Two rates are reported:

1. The percentage of ED visits for which the member received follow-up within 30 days of the ED visit (31 total days).
2. The percentage of ED visits for which the member received follow-up within seven days of the ED visit (eight total days).

Visits that occur on the date of the ED visit are acceptable.

The follow-up visit can occur with any provider.

A pharmacotherapy dispensing event within the required time frame is acceptable.
