Member Reward Card

Our Member Reward Card program offers members \$75.00 on a Visa gift card that members can use anywhere in the U.S. and District of Columbia where Visa is accepted. The reward card cannot be redeemed in any way for alcohol, tobacco products, firearms, or ammunition. Members who have an appointment with their PCP for a physical exam within 120 days of their coverage becoming effective will earn this reward.

- Members must engage with their PCP within the first 120 days of their coverage for a Physical Exam.
- Once a qualifying claim is received and processed the gift card will be sent to the member.
- Members will not need to apply for or request the visa gift card.
- Members should allow 4-6 weeks after a claim is processed and approved.
