Vendor Transition for Retrospective Review Services

Summary: Important Update Retrospective Review Vendor Enhancements

AmeriHealth Caritas Next/First Choice Next is enhancing its retrospective review operations to improve accuracy and efficiency. As part of this effort, we are updating our vendor partnerships supporting retrospective data mining and complex chart review activities, with changes occurring throughout 2026.

What's Changing

In June 2026, AmeriHealth Caritas Next/First Choice Next began transitioning these services previously performed by Cotiviti to a combination of existing and new vendor partners:

HMS Gainwell (*Expansion of Existing Services*)

- **Scope:** Retrospective Data Mining Services (previously performed by Cotiviti)
- **Effective Date:** June 19, 2026
- **Status:** Existing AmeriHealth Caritas Next/First Choice Next vendor (currently supporting TPL/COB services)
- **Provider Impact:** Minimal – this represents an expansion of services already in place

Apixio (a Machinify Company) (*New Vendor*)

- **Scope:** Retrospective Complex Chart Review
- **Effective Date:** July 17, 2026
- **Status:** New vendor to the AmeriHealth Caritas Next/First Choice Next network

Codoxo (*New Vendor*)

- **Scope:** Second-Pass Retrospective Complex Chart Review and Data Mining
- **Role:** Provides an additional layer of review after HMS Gainwell and Apixio to support a thorough and consistent evaluation process
- **Effective Date:** August 14, 2026
